



Supplementary charge sheet filed in RC-19/2018/NIA/DLI
(Arrest of armed cadres of CPI (Maoist) & recovery of arms etc)

On 8.1.19, NIA filed Supplementary charge sheet in RC-19/2018/NIA/DLI (arrest of armed cadres of CPI (Maoist) & recovery of arms etc) before NIA special court Ranchi against (i) Jharilal Mahto @ Jhari (A-18), Manoj Kumar Choudhary (A-19), Ajay Mahto @ Tigan @ Mochhu @ Anjan @ Srikant @ Vashudev @ Tiger (A-20), Chanchal @ Birsan Da @ Nirbhay @ Raghunath Hembram (A-21), Ramdayal Mahto @ Bachchan Da (A-22), Krishna Da @ Avinash @ Sourabh (A-23), Anal Da @ Toofan Da @ Patiram Manjhi (A-24) u/s 121, 121A, 384 & 120B of IPC, and sections 17, 18, 20, 21, 38, 39, 40 of UA (P) Act.

2. Case No. RC-19/2018/NIA/DLI dated 09.05.2018 arising out of PS Dumri crime no. 26/2018 dated 06.03.2018 was earlier investigated and a Charge sheet was filed on 31.08.2018 against Dinesh Manjhi @ Mahavir Manjhi @ Charlis @ Shekhar (A-1), Sunil Manjhi @ Sunil Murmu @ Sunil Soren @ Chopra Soren (A-2), Sohan Bhuiya @ Ramvriksha Bhuiya (A-3), Geeta Besra @ Reeta @ Sanjhali Kumari (A-4), Sanjoti Hansda @ Kajal Hansda (A-6), Singrai Soren (A-9) and Shanichar Hembram @ Shanicharva Hembram (A-10) before NIA Special Court, Ranchi. Further NIA placed a Charge sheet against 3 accused juveniles on 31.08.2018 before JJB, Ranchi.

3. Investigation has revealed that the members of proscribed terrorist organization CPI (Maoist) had criminally conspired, with intent to aid the organization, collected / raised funds from illegitimate sources through extortion from the local contractors / businessmen knowing that such funds are to be used for committing terrorist act, collected arms, ammunitions, explosives to commit acts of terror and for the acts preparatory to the commission of terrorist act and for the larger purpose of waging war against Government of India. In this connection ten 0.303 rifles, one carbine, one 9mm pistol, two SBBL etc, 3 lakhs cash and huge quantities of explosives (gelatin), literature were seized on 01.06.18.

4. Further investigation in the case is continuing.
